- 1. This Invitation for Prequalification follows the Metropolitan Sanitation Management Investment Project (MSMIP) Procurement Plan that appeared on the Asian Development Bank (ADB) website in November 2016.

The City of Palembang (Pemerintah Daerah Kota Palembang) has received financing from the Australian Department of Foreign Affairs and Trade (DFAT), via the Indonesian Ministry of Finance, toward the cost of construction of a Domestic Wastewater Treatment Plant and Pumping Station under the **Palembang City Sewerage Project (PCSP)**.
